RESOLVED, that in accordance with the Superintendent's recommendation, the Roxbury Township Board of Education approves and authorizes the submission of the tentative budget for the 2010/2011 school year to the Executive County Superintendent for State approval. Detailed tentative budgets are available in the Board office for public review, on or about March 22, 2010.

BE IT FURTHER RESOLVED, to acknowledge that the tentative 2010/2011 budget as described above results in a general fund tax levy of \$48,362,415 and debt service in the amount of \$2,191,817 for a total tax levy of \$50,554,232.
