#### XI. <u>SUPERINTENDENT'S REPORT</u>

- 1. Kudos to the winners of the Patriots' Pen. and a shout out to Dr. Seipp and the supervisors on making good use of our data to support student achievement.
- 2. Good evening, first I would like to point out that our new Human Resources Director is on this evening's agenda. We are very excited about that. Mrs. Ferrare is a class act with a history of hiring exemplary educators in our district. She works to create a positive culture and to build strong professional relationships. She balances high standards with a supportive nature. This hire will continue the legacy built by Mrs. Gibbs; however, when you hire from within it creates a domino effect. Therefore, we have posted for an anticipated position for principal of Franklin. We have a tentative panel that consists of many stakeholder voices from administration to teachers, but we will be looking for a parent to join us. If you are a parent with a child in Franklin and you would like to serve on this panel, please send a letter of interest to me and Mrs. Ferrare as soon as possible.
- 3. In addition to Mrs. Scheneck's comments regarding the SDF lab and efforts. A special insight that was imparted to me that I'd like to share with you because it captures the spirit of what makes this school district and community special. She shared that it took a lot of people to say "yes" to make this project work and to be able to provide this opportunity to our students from our Board of Education, our administration, and our community to our town leadership and all of those individuals connected to Habitat. It's truly amazing. Also, Frank is working to partner with Lincoln Tech towards dual credit. Frank has been invited to present at an upcoming BOE meeting so the community will learn even more. His efforts and the efforts of all of our educators and administrators who work to provide that support and guidance for our students is admirable and deserves appreciation.
- 4. Our decisions are guided by what is best for students. We work to enhance our programs and create a comprehensive educational experience that offers opportunities to all of our students. Therefore, I would like to provide you with an update on our ESSER II Funds. It has been reallocated to better address concerns in the district. ESSER is short for Elementary and Secondary School Emergency Relief and is a part of the American Rescue Plan in response to the Coronavirus Pandemic. We will be using this federal grant to support students and staff in multiple ways:
  - Lincoln Roosevelt Counselor Tara Urban 21K for two years
  - Saturday Support which includes breakfast and admin until end of school year
  - Special Education staffing and contract service
  - Tent for EMS to support an outside eating environment
  - Contact Tracing at \$35/hour, 2 hours, 5 days a week for 12 weeks
  - Instructional Aides: 2 this year, 1 next year per building K-4
  - Sub Nurses: \$285/day; 4 days
- 5. We believe in educating the whole child and part of that means partnering with all of those who play a role in developing and guiding students as they learn. We are bringing a valuable

experience to our parents and I sincerely hope that many will take advantage of this opportunity. On the next two nights, Amy McCready, author of *The Me, Me, Me Epidemic,* will provide a Positive Parenting workshop, the link will be - if it isn't already - available on our district webpage. I encourage you to attend. Every parent can use support in parenting well, a most difficult and rewarding goal. There's always something to learn and contemplate. But if you are unable to attend, please know that we will have a link available on our district webpage for your review.

- 6. We have done much to ensure a strong educational foundation for our students through our programming, the hiring of exemplary teachers and building leaders, to the design of our curriculum and putting our funding where it will make the greatest impact. We have offered Saturday Support programs and shared the resources available at the Roxbury Public Library, but we continue to look for additional resources. To that end, we are looking into a company that I've spoken about before called TutorMe which would provide instructional support for our students and I believe, be a critical resource for our teachers in promoting students' academic success. You will be hearing more about this in the months to come.
- 7. Lastly, the GlobalHi5 is on February 17th. I encourage our community to come out and enjoy the festivities, the food, and the various ethnicities that make the evening so interesting and fun.

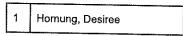
